TERMS AND CONDITIONS

1. The Club Florence (herein after referred to as “**The Club**”) will be managed and marketed by such executives/officers / nominees as may be appointed and / or authorized by “**The Club**” from time to time for this purpose. The members shall have only user rights of the facilities of “**The Club**”, as per the terms and conditions of membership/rules and regulations framed from time to time, without any claim on the property and assets of Club Florence.
2. Membership is by invitation only, and acceptance is wholly at the discretion of the management. **The membership comprises of the following components :**
 - a. **One Time Admission Fee**
 - b. **Refundable Security Deposit**
 - c. **Annual Charges**
3. The management through its Admission Committee reserves the rights of admission to “**The Club**”. Any person seeking “**The Club**” membership may be admitted as member, subject to approval of his/her application by the management and their decision shall be final in this regard. All membership charges are either one time or annual charges. Once the membership form is accepted, refund will only be applicable for Non-resident (tenant) category and refundable amount will be 50% within 3 years, 25% between 3 to 6 years and no refund will be made after 6 years.
4. The membership is open to persons above 21 years of age only. The facilities may be used by the members/their spouses, children and guests while being accompanied by the members. Members wishing their dependant children to use the Club unaccompanied, shall obtain identity card for such dependants by making a formal written request.
5. **THE MANAGEMENT** may suspend/cancel/terminate the membership of any member in case of any misconduct and or indiscipline committed by the member or his/her dependant and the decision of the management in this regard shall be final and binding on such member.
6. **THE MANAGEMENT** reserves the right to change/alter/amend any admission fee, security deposit, annual charges, subscriptions rates and charges of the services at “**The Club**” at their sole discretion at any time without notice.
7. In case of any injury and/or loss/ damage sustained by any member and/or his/her spouse/dependants/guests/attendants in the “**The Club**” premises, the management shall not be liable for any damages/claims.
8. Certain limited restrictions may apply sometimes, or in exceptional circumstances the said benefit or service may not be available. When this occurs, the management will endeavor to give advance notice but there will be no liability whatsoever on the management in this regard.
9. **Members may be asked to present their card on every visit to “The Club”**. All bills presented for any facility/services or consumption would have to be settled directly by cash or credit card. A facility to avail credit against a nominal deposit can be arranged. This credit must be settled within 15 days of submission of bills and must not exceed the security deposit amount under any circumstances.
10. All disputes, differences or questions arising out of this transaction or otherwise shall be resorted to arbitration as per the provisions of the Arbitration and the Conciliation Act 1986 with such modifications/amendments thereto and venue of such Arbitration shall always be at Gurgaon only. In respect of all the matters between The Club and any Member (s) or his/her/representative (s) only the civil courts in Gurgaon shall have jurisdiction. The membership is **Transferable** to any **ONE** of successor in case of an evenuality of primary applicant.
11. Any member bringing guests to “**The Club**” must enter their names in the Guest Book. Guest Charges will be charged as applicable from time to time and notified to the members.
